Submission Guidelines:

Abstracts must be no more than 300 words, clearly stating the research problem, objectives, methodology, and key findings.

Full papers should be a maximum of 8000 words, including references, tables, and figures. All submissions must be in English and adhere to the conference's formatting guidelines. Papers should be original and not simultaneously submitted to another journal or conference.

All papers will undergo a double-blind peer-review process.
